UNITED STATES Dir Lee Gordon gave over 40 presentations throughout the US in synagogues, churches, mosques & in home hosted parlour meetings, where he discussed the work of Hand in Hand (HIH) in Israel & the state of Jewish-Arab, Israeli-Palestinian relations in Israel. Work was begun to create a HIH Council of Clergy, made up of Jewish, Christian & Muslim religious leaders in the US. Mr. Gordon arranged 2 speaking tours of HIH representatives from Israel who spoke to audiences in New York, Baltimore, DC, Los Angeles, San Francisco, Houston & Philadelphia. He also arranged for the Israeli Director of the Center, Mr. Shuli Dichter, to come to the US to speak at 2 conferences. One at Rice University in Houston & 1 at a conference in DC. Regular informational updates & articles describing the work of HIH, as well as media articles about the situation in Israel were prepared and sent out to a list of 3500 people. In Dec 2014, 2 Hand in Hand high school students were invited to the White House by President & Mrs. Obama where they spoke & participated in the White House Hanukkah party.
