The Executive Vice President and General Counsel and the Vice President of Marketing & Communications have severance agreements with MHA. If MHA severs their employment, MHA will provide severance benefits equal to thirty-nine weeks of base salary and associated benefits, without offset, and an additional thirteen weeks' severance, offset by salary of subsequent employment. Severance benefits will not apply if the cause of the termination is due to willful misconduct, gross negligence, or an illegal act.
