The Campaign for Excellence is a program directed towards significantly renovating TMH's Emergency Department (ED) to provide the capacity, privacy, and efficiency that the community needs These renovations have improved patient transportation, work flow, and collaboration among team members This program also involved building a Procedural Care Unit (the Unit) suited for cardiology and endoscopy patients treated at TMH The Unit consists of 21 beds adjacent to the ED, focusing on cardiac catheterization and electrophysiology Cardiac care has been enhanced, additional beds for inpatient care have become available, and faster admissions through the ED have been facilitated

The Foundation maintains another large permanently restricted endowment fund, the income from which is donor-designated for the general use and purposes of the Department of Cardiology at TMH. Income from the Foundation's other notable permanently restricted endowments is for the general use and purposes of TMH and also supports: (1) education and research in TMH's Department of Medicine, (2) neuroscience research, (3) the geriatrics program, (4) and nursing scholarships. The largest temporarily restricted funds maintained by TMHF are used to support the Capital Campaign Building Fund at TMH and the Campaign for Excellence, which uses donations to support both ED renovations as well as a Procedural Care Unit (the Unit). The Unit is suited for cardiology and endoscopy patients treated at TMH and consists of 21 beds focusing on cardiac catheterization and electrophysiology. Other significant temporarily restricted funds of the Foundation sustain clinical shared chairs with the Warren Alpert Medical School of Brown University in geriatrics, cardiology, immunology, and oncology, as well as support the operational needs of TMH's ED. TMHF's unrestricted endowment supports spending priorities at TMH collaboratively established by the management of TMH and TMHF and approved by TMHF's Board, and also defrays fundraising expenses.

A master database of the Foundation's temporarily restricted funds is maintained as the primary source for identifying each fund's restriction, the availability of the current balance, and the authorized personnel for the respective fund. The database contains the fund's name, primary reporting department, most recent month end balance, fund purpose/restriction, and the management responsible for the fund. Expenditures (purchase requisitions, work order requisitions, check requests, and employee reimbursements) from TMH's temporarily restricted funds must be presented to the Lifespan Finance Department for approval prior to processing. Each request is reviewed to ensure the availability of funds and that the expense/purchase is both in conformity with the fund's restriction and approved by the required levels of authorized personnel referenced in the database. Additionally, the Foundation made grants from its unrestricted net assets to TMH in the amount of \$1,322,055 in fiscal year 2015 in support of spending priorities collaboratively established by the management of TMH and the Foundation and approved by the Foundation Board. The Foundation and Brown University (Brown) have several agreements pursuant to which each entity maintains endowment funds representing 50% of certain endowment gifts which support various clinical shared chairs. Each agreement specifies a spending rate which is applied to the trailing three-year average fair value of the applicable endowment funds to arrive at an amount used to support the named Professorships. Payments distributing these amounts are made by the Foundation to Brown on a quarterly basis. Under the terms of the agreements, Brown is required to provide an annual accounting to the Foundation sixty days following the anniversary of each agreement.

The Foundation also furnished \$150,000 in support of research infrastructure within TMH's Total Joint Center, a center of excellence dedicated to providing state-of-the-art specialized procedures, rehabilitation, and care to restore function to damaged hips, knees, and shoulders. Finally, the Foundation transferred \$70,000 to TMH to fund an initiative on addiction and overdose prevention.

No less frequently than annually, the Committee receives and reviews a total cash compensation valuation of all existing executive compensation program participants prepared by its independent compensation consultant. Annually, the Committee also receives and reviews a total remuneration valuation of all existing executive compensation participants. Base Salary Actions. The CEO recommends any salary adjustments for participants in the executive compensation program, using the results of the valuation study and his/her assessment of individual performance or other pertinent information, for the Committee's consideration. New Participants in Executive Compensation Program. With respect to compensation offers for individuals expected to participate in the executive compensation program, certain members of the Lifespan CEO's Council work with the Committee's independent compensation consultant or relies on information previously provided by the consultant to establish a range of reasonable cash compensation within which recruitment is expected to conclude with acceptance of a reasonable compensation offer.
