During fiscal year 2015, Bradley Hospital Foundation (the Foundation) transferred \$438,974 in funds raised to EPBH to support the continued expansion of its outpatient services, in response to growing demand. This expansion allows the outpatient services departments to better serve the community by reaching more children and families in need of mental health care, as well as improving the quality and environment of that care. The 2,284 square foot addition included more space for group therapy which allows Outpatient Services to accommodate the increased patient volume in that area.

Through the development and administration of philanthropic activities, the Foundation is able to transfer various funds raised to EPBH to support its operating activities, which in turn benefit the Rhode Island community. For example, in fiscal year 2015, some operating activities of EPBH that the Foundation supported include the Outpatient Child Psychiatry Department's Group Therapy Program, the Fostering Mental Health Clinic, and the Pediatric Mood Imaging Neuro Development program (PediMIND). Please see Schedule O of the Form 990 for more detail related to the support of these programs.

The Foundation also transferred \$148,068 to EPBH to support the general purposes of the Intensive Program for Obsessive-Compulsive Disorder (OCD), including the purchase of equipment. This program provides treatment to children and adolescents ages 5 to 18 who experience significant impairment in their daily lives due to OCD and obsessive-compulsive spectrum disorders. The program's goal is to alleviate symptoms while improving daily functioning and promoting further involvement in school, social, and family activities.

FORM 990, PART III, LINE 4B	Through the development and administration of philanthropic activities, the Foundation is able to transfer various funds raised to EPBH to support its operating activities, which in turn benefit the Rhode Island community. For example, in fiscal year 2015, \$98,000 was transferred to EPBH to support the Outpatient Child Psychiatry Department's Group Therapy Program. This program offers comprehensive mental health evaluations and treatment to children, adolescents, and families from southern New England. The type and extent of treatment depends on each patient's needs. EPBH's group therapy programs include "iFriend: A Social Skills Group" (iFriend), "Incredible Years: Positive Parenting for Challenging Kids" (Incredible Years), "Mindful Teen", "Teen Anxiety Group (TAG)", and "Tic Talk". iFriend helps children in elementary school (ages 8-11) build friendship skills, practice conversation, and learn to cope with challenges through structured lessons, activities, and games. Incredible Years is a skill-building course for parents to learn effective ways to help children with behavioral challenges learn calming techniques, follow directions, and get along with others. Mindful Teen uses a dialectical behavior therapy approach to help teens with rapidly changing moods manage their emotions and reduce impulsive and self-destructive behaviors. TAG uses cognitive behavior therapy to help teens overcome anxiety, stress, and worry to better enable them to achieve the life that they desire. Tic Talk uses comprehensive behavior therapy to help youth with tic disorders and Tourette Syndrome learn skills to manage and reduce tics. \$64,556 was transferred to support programmatic fees associated with the development of the Fostering Mental Health Clinic at EPBH; also, \$50,212 was provided in support of the Pediatric Mood Imaging Neuro Development program (PediMIND), which uses brain imaging techniques, including magnetic resonance imaging (MRI), behavioral measures, and genetic analyses, to identify biological and behavioral markers (scans and tests) of psychiatric illness, including bipolar disorder, in children and adolescents. Additionally, \$47,812 is to be used to support the Mind-Body Wellness Initiative at the Bradley School in Portsmouth, including the purchase and installation of an outdoor fitness system. \$40,399 was transferred to EPBH to help New port Child and Adolescent Behavioral Health Clinic outpatient families with transportation to EPBH's Adolescent Partial Hospital Program in East Providence when day treatment services are not available in New port County.

The Chair of the Committee conducts and documents this review, based on his/her observations and interpretation of feedback from members of the Board of Directors * Selecting and engaging qualified, independent, third party compensation valuation consultants that the Committee charges with rendering opinions with respect to the reasonableness and comparability of compensation as well as the comparative organizations against which compensation is assessed, in accordance with relevant sections of the IRC and Lifespan's executive compensation philosophy. No less frequently than annually, the Committee receives and reviews a total cash compensation valuation of all existing executive compensation program participants prepared by its independent compensation consultant. Annually, the Committee also receives and reviews a total remuneration valuation of all existing executive compensation participants. Base Salary Actions. The CEO recommends any salary adjustments for participants in the executive compensation program, using the results of the valuation study and his/her assessment of individual performance or other pertinent information, for the Committee's consideration. New Participants to Executive Compensation Program. With respect to compensation offers for individuals expected to participate in the executive compensation program, certain members of the Lifespan CEO's Council works with the Committee's independent compensation consultant or relies on information previously provided by the consultant to establish a range of reasonable cash compensation within which recruitment is expected to conclude through acceptance of a reasonable compensation offer.
