The Bowery Mission - CHA offers Compassionate Care to meet the immediate physical and emotional needs of each guest. The following services are offered to both men and women, free of charge: chapel services three times a day, cooked meals three times a day, daily overnight shelter in the winter, showers, haircuts, and clothing, crisis intervention counseling, a weekly medical clinic and monthly optometric clinic, and daily outreaches to street corners and parks in Manhattan and Brooklyn. Each service we provide is an invitation to a deeper life change. We facilitate Life Transformation in our residential recovery programs for both men and women, which incorporate one-on-one and group counseling, addiction recovery and family restoration programs, Career Centers offering tutoring, computer and vocational skills training, and job preparation, and participation in daily work, worship, and Bible studies. In 2015, 49 men and women graduated from our men's and women's residential recovery programs. Each graduate exhibited specific evidences of future success by which we measure progress. In 2015, in addition to our 49 graduates, The Bowery Mission provided approximately 406,000 meals, 44,700 bags of groceries, 91,500 nights of shelter, and 44,100 articles of clothing, as well as showers, haircuts, and 673 professional doctor's appointments and eye examinations at our in-house clinic. Our work was supported by more than 30,000 donors, 44,000 volunteer hours, and \$3.2 million of noncash donations. Volunteers prepare meals and provide other basic services, serve as teachers, mentors, and tutors, offer professional services ranging from medical care to legal counseling, and raise financial and in-kind support for The Bowery Mission.

Mont Lawn Camp and City Camp - Our children's programs reach out to children from low-income families around New York City through a coordinated program which effectively and measurably changes their life direction. During the year, we offer children and their families character building mentoring, enrichment activities, and horizon-broadening experiences. Programs include Mont Lawn Camp (summer camp), City Camp (our year-round youth development program) which also includes Leadership Academy (a mentoring program for youth who participate in City Camp). CHA served more than 1,200 children with summer camp and year-round programming.
