Specifically, CitizenLink sent newsletters, mailers and regular emails to households across the nation. In addition, CitizenLink used telephone technology to alert citizens to important issues affecting the family in their state, developed online resources, including a website and web videos, as well as aired a radio program on nearly 500 stations. These communications were designed to rally CitizenLink members and the general public to raise their voices on issues such as God's design for marriage between one man and one woman, the sanctity of human life from fertilization to natural death and the protection of religious freedom and rights of conscience.
