Most of the money we make goes directly to pay school fees and school expenses for orphans and vulnerable children in
Zimbabwe. In total, we fund 43 students. Of these, 19 attend local schools (\$ 23,815), 11 students attend technical shools
(\$ 26,650), 9 attend boarding schools (\$ 29,158) and 4 are at university (\$ 8,164). In addition to the cost to attend school, we
cover medical fees, tutoring, prizes for outstanding academic achievement, and emergency food packs (\$ 6350), and
sports programming (\$ 5,000).

990-EZ - Part I: line 16: Other expenses

This year we spent \$ 380 taxes and fees to file attorney general forms in several states, \$ 7381 for two trips to Zimbabwe,
\$ 3979 in bank and wire transfer fees, \$ 1746 in office supplies

990-EZ - Part II: line 26a

At the start of the year we owed \$ 387 to a credit card. This was paid and we ended the year with no money owed.
