CARE continued to provide funding to support the breast cancer research of Dr. Barbara Pockaj and others, of the Mayo Clinic. The Precision Therapeutics program (formerly known as GKG-Genomic Knowledge Geneartion) is focused on exploiting genomic discovery & validation to develop clinical trials and therapeutics for patients with breast cancer. New projects include a clinical trial using anti androgen and selective receptor modulators and the correlation of patient outcomes with genomic data. Dr. Erik Castle of the Mayo Clinic has been the driving force behind the prostate cancer research we have funded over the past 7 years. During that time frame, and with our funding, he has been able to expand the bio bank to over 40,000 specimens of urinary cancer and benign tissues from prostate cancer, and other genitourinary cancers, including bladder & kidney cancer. These specimens provide the foundation for much of his work. As a result of this extensive bio bank, Mayo Clinic has contributed samples to the "Cancer Genome Atlas" at the National Institutes of Health. Projects underway include perfecting a platform for the identification of circulating tumor cells in cancers and certain gene expression profiling. This year funding will continue to support continued expansion of bio banking, research support and laboratory supplies.

CARE funded the hiring of Dr. Erkut Boraznci, MD, as the Medical Director of the newly established Early Detection Program at the Virginia G. Piper Cancer Center at HonorHealth (formerly Scottsdale Healthcare). This program is working initially with individuals at high risk for pancreatic cancer by conducting medical history and physical exam, genetic testing & counseling, blood testing and MRIs and other imaging studies. Participants receive comprehensive review of risk factors, multiple ways to reduce their risks and a personalized plan for cancer prevention. The program already has 30 participants, with 20 unique inherited genetic mutations already found. Several have been referred for surgical evaluation for pancreas, as well as other cancers. Through this program, vital data is being gathered to help identify common patterns, characteristics and trends that may help to intercept and defeat cancer at much earlier stages than possible before. Dr. Ronald Korn, who is the Medical Director of the Virginia G. Piper Cancer Center at HonorHealth, continued his efforts in making the Rapid Detection and Assessment of Response (RADAR) program a reality. This technology uses non-invasive, highly specific analytic tools and imaging techniques to monitor a patient's response to chemotherapy or radiation with a goal of determining within a few days whether a patient's treatment is working. This technology is being used in part to determine sensitivity for detection of cancer, prediction of tumor aggressiveness on mammograms and tumor responses in certain clinical trials. Funding for 2015 enabled the program to go from the research phase to the trial phase in evaluating patient scans vs. physical properties of tumors.

We host seminars and presentations with researchers, physicians and experts from HonorHealth (formerly Scottsdale Healthcare) and Mayo Clinic to address a wide variety of topics for multiple audiences at the Desert Mountain community.
