The organization provided scholarships for 10 children and 2 adults to participate in 12 classes at the Frisco Athletic Center. The classes included recreational and educational programs such as dancing, ballet, tumbling, skating, soccer, zumba and dodgeball. Selection of the recipients was based on financial need. The scholarship assistance program achieved the organization's mission of providing and expanding charitable and educational/recreational services to the citizens of Frisco, Texas.

4b (Code:) (Expenses \$ 3,300 including grants of \$) (Revenue \$)

Frisco Fire Safety Town, operated by the Frisco Fire Department, received \$3,300 for educational projects for children and families. Fire Safety Town provides safety training through classrooms and interactive fire engines, safety houses, and a mini-Frisco town with small buildings, paved roads, street signs, working crosswalks, and railroad crossing signals. Fire Safety Town provides fire, home, traffic and weather/tornado safety training for children, which furthers the mission of expanding education services to the citizens of Frisco.

\$1,000 was provided to the Frisco Fire Department, as requested by the donor, whose kindergarten child had participated in the Fire Department's elementary education outreach program. This assists the expansion of educational projects for the citizens of Frisco.
