We store clothes, furniture, and other household items, so when a child has to be moved quickly we can provide needed items immediately Also, we use these items to help those who have lost their homes to fires
- 4 We have also purchased and renovated a house to be used by the Pee Dee Coalition Against Domestic and Sexual Assault which is an organized 501(c)3 This house is a private location for people who have been assaulted to come for help We pay some of the expenses on the house such as insurance and maintenance Within the house we have set up rooms to be used for classes and training on what to look for and help prevent domestic and sexual assault Our treasurer, Teresa J Mason, also serves on the board of the Pee Dee Coalition Against Domestic and Sexual Assault
