Donations are made to organizations recognized by the IRS as being described in IRC Section 501(c)(3). All contributions are approved by management and are made to organizations whose missions and goals align with those of NHF. NHF also engages in philanthropic activities to support the mission and purposes of Newport Hospital, a related 501(c)(3) organization. In the 2015 fiscal year, NHF made unrestricted net asset transfers to Newport Hospital totaling \$8,712,263, \$8,300,000 of which Newport Hospital used to fund operations, debt service payments, and major capital expenditures. The additional \$412,263 was provided to Newport Hospital as temporarily restricted net asset transfers in support of certain building and equipment additions or specified clinical programs. NHF also transferred \$8,765,857 to NHCC Medical Associates to support its operating activities. The use of funds is monitored by NHF's management group to ensure that the funds are utilized for intended purposes. Financial and third-party verification is reviewed depending on purpose and outcome.
