In 2015, St Vincent's Foundation's "Swim Across the Sound" campaign celebrated its 28th anniversary Since 1987, the SWIM has raised funds to offer 45 different cancer education, screening and support services to cancer patients and their families In total, the Foundation provided approximately \$751,500 in support to SWIM programs during the fiscal year ended September 30, 2015 The SWIM offers a significant safety net to our region by providing one-on-one financial assistance to cancer patients in the community In addition, the SWIM is dedicated to cancer prevention and early detection Our mobile mammography program offers low-cost and free mammography screenings at community-based senior centers, churches, synagogues and other local facilities for the medically under served, at risk women of southern Connecticut The SWIM also helped cancer patients and their families through cancer support groups, nutrition classes, yoga, music therapy and massage for cancer patients, Sunday brunches for oncology patients and their families, transportation needs for non-ambulatory cancer patients undergoing treatment, subsidized nausea medication for patients receiving chemotherapy, purchases of prosthesis and wigs for cancer patients, subsidized at-home hospice assistance, and subsidized nutritional counseling The Swim also underwrites our Teen Smoke Stoppers program, the only one of its type in Connecticut, which is primarily offered through the school systems During FY2015, approximately 25,000 students in 150 regional middle schools, high schools, and colleges attended smoking prevention lectures geared toward teenagers and 15 students and 30 adults enrolled in smoking cessation classes

During FY2015, St Vincent's Foundation provided approximately \$268,000 in support of the operations of its affiliate, St Vincent's College Funds provided by the Foundation enabled the College to grant approximately \$265,500 in scholarships or awards to students attending the College These scholarships are subject to academic, as well as financial needs criteria The Foundation also provided funds through the end of calendar year 2014, in collaboration with the CT Challenge, to implement a "cancer survivorship" curriculum across all degree programs at the St Vincent's College

During the fiscal year ended September 30, 2015, St Vincent's Foundation released approximately \$267,700 to its affiliate, St Vincent's Medical Center, to subsidize the cost of various Medical Center programs for which there is no other available funding source One of these programs is the Ima D'Addario Wellness Booth at the Medical Center During FY2015 the Wellness Booth provided free blood pressure checks and blood sugar and cholesterol screenings The Foundation also helped subsidize the Integrative Oncology center, Diabetes and Pancreatic symposiums, our "Women at Heart" care club (for heart-related diagnosis, education and treatment specifically for women), and provided free public lectures on prostate cancer and free prostate screenings for at-risk men The Foundation also subsidized the Hope Dispensary of Greater Bridgeport which provides short-term and long-term medication assistance to eligible patients (where a majority of patients are below the 200 per cent Federal Poverty Level)

In addition to the above, the Foundation provided approximately \$432,200 in funding to support other programs of its affiliates, St Vincent's Medical Center, St Vincent's College, and St Vincent's Special Needs Services. A portion of this funding was from Employee giving campaigns conducted at St Vincent's Medical Center and St Vincent's Special Needs Services. St Vincent's is committed to reaffirming its outreach to the vulnerable and medically underserved. This commitment is shared by employees who have generously contributed year after year to the Employee Giving Campaign. During FY 2015, this campaign provided approximately \$243,000 in assistance to families who were in dire need of food, bedding, and clothing. This fund also assisted families who were at risk of becoming homeless or required emergency assistance with utility bills. During FY 2015, the Foundation also released approximately \$189,000 in additional support to programs of its affiliates. Most of this was in support of St Vincent's Special Needs Center. The support provided to Special Needs assisted in the capital needs of the center and assisted with the cost of program enrichment activities provided to Special Needs clients.
