In 2002, The New Hampshire Rockingham County Superior Court ruled that all grants required by the Internal Revenue Code in order to avoid excise tax on undistributed income must be distributed to the Alexander Eastman Foundation. For the year ended 9/30/14, Harrison Alexander Trust approved a grant of \$31,855 to the Alexander Eastman Foundation.
