The Board of Directors shall hold annual meetings, at least quarterly, at such times and places as the officers shall determine. - This changes the date of the annual meeting from between June 1 and September 30, to between September 1 and October 31.
2) Article IV, Section 4.5: Terms. Within thirty days prior to or at the Annual Meeting of the Corporation, the outgoing Board of Directors shall elect incoming Directors to fill the vacancies of those Directors whose terms are expiring, and the new Directors so elected shall serve for a term of three years. Directors may be re-elected to serve for additional terms of three years. These elections can be held by electronic voting or in person within thirty days of or at the Annual Meeting. - This changes the elections from being held at the Annual Meeting, to allowing them to be held within thirty days of the Annual Meeting, and allowing electronic voting.
