During Fiscal Year 2015, the Foundation directly contributed \$7,291 to Brevard Urgent Care/Frances Warde Family Health (FWFH) for purchase of a new EKG machine, other minor IT equipment and also help support FWFH indigent population by providing funds to cover medical treatment.

Primary-care services are offered through Frances Warde Family Health in Brevard. This practice offers a diabetes education and treatment program in conjunction with Transylvania Regional Hospital

Brevard Urgent Care and FWFH, both located in Brevard, NC, saw a combined total of 6,265 patients in FY 15

During FY 15, \$18,154 of direct expenses were used toward our medical mission program in Haiti. Staff and other volunteers from Sisters of Mercy Urgent Care and Sisters of Mercy Service Corp. provided care to 1,381 Haitian patients during 3 mission trips. The internal cost of preparation and value of volunteer time is estimated to be around \$48,621

During FY 15, the Foundation supported Sisters of Mercy Urgent Care (SOMUC) by providing funds that supported a collaboration with SOMUC and Mountain Area Health Education Center (MAHEC). MAHEC provided a sports fellow at our Urgent Care center for 8 hours a week over 6 months in FY 15.
