Employment and Education for Transitioned-aged Youth - MANY is the creator of the Positive Pathways Program (P3), a multi-level strategy to reduce community violence and improve the long-term labor market prospects of juvenile offenders The target audience for this program are youth aged 16 to 24 from high-poverty, high-crime communities P3 connects Individual Pathway Coaches with youth involved in the juvenile justice system and in at-risk situations to provide youth with a menu of holistic services Performance measures for youth who enrolled a minimum of 9 months include 88% placed and stabilized in employment and/or education, 56% attained a degree or certificate, and 03% recidivism

Mentoring Models for youth at highest risk for juvenile justice involvement - Grounded in evidence-based practice, the goal of the Mentoring+ program is to reduce juvenile delinquency for children and youth who are at-risk or at high-risk of involvement in the juvenile justice system (including children with an incarcerated parent) by increasing protective factors that will build resiliency The Mentoring+ program model demonstrates positive outcomes serving these vulnerable youth (including children with an incarcerated parent) 85% mentor retention rates, 99% of mentees have not offended or re-offended, 99% of mentees maintained school enrollment, and 89% of mentees demonstrated increased social competence To date, our Mentoring+ chapters are in 46 states and together they served over 115,366 youth and their families last year alone
