Therefore the donation of food is calculated as $\$2,080 \times 52 \text{ weeks} + \830 of extra food by SVDP members to total \$108,990. On average the food item donated has a retail value of \$5. Thus, $\$108,990/5 = 21,798$ pieces of food donated annually.
