	Capital for Good and CfG Impact offer donor's innovative, flexible and efficient ways to contribute to life changing projects. This methodology enables donor's the option to fund individually or collaboratively to leverage funds and impact. We achieve this mission by partnering with the most capable organizations, especially community based ones who are located outside of the US, in order to achieve the best results for the donor. During this current fiscal year Capital for Good successfully created two humanitarian funds, The Ebola Crisis Fund and the Nepal Earthquake Recovery Fund. CFG granted over \$650,000 to the Ebola Crisis through community based organizations in Liberia, Sierra Leone & Guinea which directly helped over 5.7MM people through the crisis. Interventions supported included immediate relief, prevention & mitigation efforts and eventually helping the survivors. CFG then funded almost \$100,000 to victims of the Nepal Earthquake by delivering immediate relief including building supplies, food, and clothing to local community based organizations working with vulnerable hard to reach populations severely impacted by the earthquake and aftershocks. The six grants that were made impacted over 15,000 individuals. Ongoing programs continued to thrive as well. The Advocacy Initiative, a global health fund, has granted \$9.6 million since 2011-\$1.82 million in the last year-to organizations advocating for a range of global health and development issues. Examples of the Advocacy Initiative projects in the most recent year include seed funding for a South Africa-based organization to increase awareness of TB in the medical community, support for a major international association to launch and evaluate a new approach to HIV/AIDS advocacy, and funding for a national coalition on nutrition to develop their first advocacy strategy. The Malawi Early Childhood Development program started in 2013 is now in its final 6 months of activity. To date over 10,000 pre-aged children have been introduced to the alphabet & numbers through 128 early childhood development centers. They now have foundational learning skills and are better equipped for enrollment into the formal primary schools. Additionally 3 of 4 planned grinding mills are operating and generating revenues to substitute the programs expenses so that these pre-schools will continue to operate even after the program close out. The Integrated Fund for Gulu was launched in 2015 with seed funding from a donor. This initiative recognizes that the complex and interconnected nature of life should be reflected in development practice. We believe that for sustainable development to occur, growth within a variety of sectors must be simultaneously pursued. The Fund is made up of sub-portfolios within each sector, containing projects that provide complementary growth across sectors and fueling regional growth. Our initial grants to date include agriculture, business & health related activities with further expansion planned as additional funding is received. A majority of the Fund's 2015 activity focused on sectoral mapping and strategy development. In the 2014-15 fiscal year, three small grants were also placed totaling \$30,373.
