DURING THE TRIP, CYCLISTS ARE EDUCATING COMMUNITIES AND SPREADING AWARENESS OF MULTIPLE SCLEROSIS IN PERSON, ON TELEVISION INTERVIEWS, NEWSPAPER ARTICLES, AND VIA SOCIAL MEDIA. CYCLISTS ALSO STOP TO VOLUNTEER FOR INDIVIDUALS LIVING WITH MS ACROSS THE NATION.
