Breathe EASY - Home Visiting project  
 Breathe Easy Asthma Home Visiting Project, funded by a grant from the DC Health, conducted in-home environmental assessments for asthma patients, providing medical asthma case management, distribution of air quality improvement tools, and referral services for children at high risk of asthma attacks. The program succeeded in delivering 83 initial home visits, 59 follow up home visits, and enrolling 12 individuals in smoking cessation, including the DC Quitline group counseling, and text services.

Cessation & Health Equity  
 Cessation Health Equity Program in partnership with AmeriHealth DC, Breathe DC created accessible smoking cessation classes integrated into AmeriHealth DC's health system, which serves more than 110,000 District members through a network of more than 3,000 providers. The project supported AmeriHealth DC to intergrate sustainable cessation services into its health system, to increase cessation service accessibility and to increase among its members a knowledge and awareness around smoking and the far-reaching health risks associated with smoke exposure. The five-month project was funded by the DC Department of Health and served

Smoke Free Places  
 Aimed at reducing exposure to secondhand and thirdhand smoke, and creating healthier living environments, the Smokefree Places project educated 13 landlords and property managers at 403 housing communities with more than 1,842 tenants. The project disseminated cessation information, made referrals to cessation programs and educated landlords and tenants about the financial benefits of smoke-free housing. The five-month project was funded by the DC Department of Health
