We have developed free, compelling media resources, highlighting the needs of the world. Prayercast.com has been accessed by people from over 150 nations and viewed by people from all 50 states each week. Churches and mission organizations have used Prayercast videos to spark powerful times of corporate prayer. We seek to proclaim the gospel through our active interaction with our partner, OneWay Church, in ministering to people in the Aurora/Naperville area of Western Chicagoland. We are also partnering with ministries around the world to further the impact of local churches and ministries into their communities in which they exist. OneWay produces and distributes music CD's with worship music to Christians around the globe and each year ministers to hundred's through our annual Shine concert. The aim of the concert is to encourage people from various backgrounds, cultures, and churches to come together and worship Jesus. OneWay partners with organizations, churches, and schools to accomplish our mission and further the gospel of Christ in our nation and around the globe.
