BROAD K-8 CENTER, NORTH BEACH ELEMENTARY AND TREASURE ISLAND ELEMENTARY - PREVIOUSLY DID NOT HAVE ACCESS TO MEDICAL ATTENTION, BUT THANKS TO THE EFFORTS OF THE FOUNDATION AND THE UNPRECEDENTED COLLABORATION WITH FIVE MUNICIPALITIES AND MORE THAN A DOZEN ORGANIZATIONS, THEY NOW DO. EACH SCHOOL NOW HAS A NURSE, MEDICAL ASSISTANT AND SOCIAL WORKER ON STAFF.
