The country has a very high rate of poverty and the hospitals and clinics provide for much needed medical care to many people living in poverty in homes made of mud and landfill materials. The Organization supports ongoing breast cancer projects at hospitals and clinics throughout the Philippines. These programs make the difference between life and death for thousands of sick people.

The Organization provided for ongoing monetary grants to Oasis of Hope Hospital in Tijuana, Mexico. Oasis takes a total approach in treating individuals with breast cancer: spiritually, mentally, and physically. Oasis also promotes holistic cancer treatments that have proven to be effective. The Organization supports programs in Europe that help women with breast cancer thru research, prevention, early screening, and alternative treatments.
