A significant portion of IMEC's costs are incurred by IMEC's subrecipients that assist the organization in transferring manufacturing technology to Illinois manufacturers. Of the \$5,140,769 in subrecipient expenditures, \$5,062,526 is classified as program service and \$78,243 is classified as general and administrative.
