Grants provided in the fall to teachers who apply for classroom based funding. Grants of up to \$250 are provided for such expenditures as: library books, calculators, chess sets, smart boards and activity boxes, etc.

Grants are provided in the spring to teachers seeking larger capital needs. Grants range from \$500 to \$10,000 and are provided for such grants as: PACT programming, ABA Program, 3D Printer, High School Option Program, Spatial Temporal Math for Elementary STEAM Magnet School, High School STEAM Academy, Elementary School Kindergarten Station Academy. The Foundation works in partnership with a private foundation in securing the funds for these grants.

Student Field Trips

Through the Kids in the Community field trip program, Cedar Rapids public school students are provided the opportunity to experience hands-on learning at many of the cultural, educational and historic sites in and around our community. High School Senior Scholarship recipients are selected each year by the Administration of the community high schools. Scholarships are awarded to the students selected. The

scholarships are submitted directly to the college/trade school of the student's choice.

Student field trips are awarded upon requests submitted by teachers and principals through the Cedar Rapids Community School District (CRCSD).

Student Enrichment grants of up to \$250 are provided in the fall to teachers who apply through CRCSD to CRCSD for classroom-based funding.

SAFE program is described in detail in Schedule O in response to Form 990, Part III, Question 4d. The programs are monitored by the CRCSD.

School Project Grants, ranging from \$500 to \$10,000, are provided in the spring to teachers for large, capital needs. The projects are recommended and monitored by CRCSD.

Professional Development Grants are awarded to community school district educators, who submit applications for assistance in furthering their educational development.

The Foundation serves as the fiscal agent for various programs that have a relationship with the CRCSD in various capacities. The Foundation receives contributions for these programs

and dispenses the funds to support specific activities of the program's choosing within the CRCSD.

However, such interested party may be present to provide clarifying information in such discussion or debate unless objected to by any present board or committee member.

Anyone in a position to make decisions about spending CRCSDF resources, who stands to benefit from that decision, has a duty to disclose that conflict as soon as it arises (or becomes apparent). Such person should not participate in any decisions regarding such transactions.

Any conflicts of interest will be noted in the minutes of meetings.
