Emergency Assistance - Inspired by Gospel values, the Society of St Vincent de Paul, a Catholic lay organization, leads woman and men to join together to grow spiritually by offering person-to-person service to those who are needy and suffering. Our neighborhood-based, volunteer-run chapters, provide financial assistance to people facing eviction, hunger, threat of disconnection of utilities and other emergency needs. Through the work of over 3,540 volunteer members, 142 St Vincent de Paul chapters and the council office provided \$7,695,325 in assistance to over 290,911 people in 2015. In addition to the assistance provided by the local chapters, the St Louis Council's professional staff provides services that are beyond the scope and capacity of the chapters. These services include a car donation program that provides people in need with car repairs or operational vehicles, a utility program that helps people avoid disconnection, a pharmacy program that provides free medication, and a burial program that provides a dignified resting place to those who die without family to bury them. In 2015, the Council Office's programs provided \$1,055,891 in assistance to 10,149 people in need.
