Our educational supports extend to providing on-going technical assistance to tribal leaders building and maintaining their tourism infrastructure. Aianta is also investing in the next generation of tribal leaders in tourism. In 2015, Aianta hosted the third annual Enough Good People Silent Auction and Awards Ceremony which to date has raised the funds to support 9 Native American students pursuing an education in the tourism and hospitality industry. --Educational outreach and promotion Aianta's unique collaborative approach has ensured native communities contribute to and share in the benefits of the travel industry including job growth, increased revenue, strengthened culture and community development. Our board and/or staff participated in 18 speaking events locally and globally to tourism industry representatives to promote tribal tourism across the United States. In 2007, Aianta expanded our outreach and promotion to include international travelers by participating in ITB Berlin, Showcase USA-Italy, U.S. Travel Association's International POW WOW, and the China International Travel Mart. Aianta, in addition to presenting, provides training to all participating tribes prior to show attendance. We are beginning to see results from this investment, with international travel to Native American sites showing steady increases each year with 1.65 million visiting Indian Country in 2014 (Dept. of Commerce), particularly from the markets we have focused on in our efforts--China and Europe. Our staff and board in-person outreach and promotion is supported by Aianta's public relations and marketing efforts resulting in 14,500 website visitors, 217 news stories, 3,420 Facebook likes, 705 Twitter followers, and 422 Pinterest pins in 2015. --Public Lands Partnership Grand Canyon National Park's Desert View Intercultural Heritage Center and Native Artists Program, in partnership with ArtPlace America, was launched to begin the process of repurposing the Desert View Visitor Area and historic Watchtower into an inter-tribal gathering place and first-voice interpretive center. Aianta brought together the following partners to successfully implement this project: Grand Canyon National Park, the Inter-Tribal Advisory Council (ITAC), including Hopi, Navajo, Zuni, Havasupai, Hualapai, Yavapai-Apache and the 5 bands of Southern Paiute to be represented by the Kaibab Paiute, the Bureau of Indian Affairs (BIA), Grand Canyon Association (GCA), and the American Express Foundation. --American Indians and Route 66 The American Indians & Route 66 Guidebook and the production of the American Indians and Route 66 COM project was launched in November 2014 and completed in December 2015 in partnership with the National Park Service (NPS). The guidebook and website provide a history of the tribal homelands of the 27 Indian tribes along the route from Chicago to Santa Monica, California including 17 national parks in 8 states. This project invites and guides visitors as they explore the unique history of historic Route 66. --Spatial Data Infrastructure Launched in 2015, Native America Travel is the first destination website to promote Indian Country tourism to the world. The website provides American Indian, Alaska Native, and Native Hawaiian attractions, activities and lodging, narrative experiences, photographs and videos, and an interactive and filterable map. In 2015, Aianta also launched our web-based resource library to disseminate to tourism strategies, guidance, and research in tourism development and management. Our staff also conducts research and compiles tribal tourism data to support and inform the development and growth of tribal tourism.
