Programming activities for positive youth development require both fiscal support through donations and the active solicitation of club members. The funding allows for the purchase of materials used in activities. Through these activities, youth develop leadership abilities, skill-based competencies, and critical thinking skills. Fundraising is guided by volunteer leaders and carried out by members in the local 4-H clubs, each with a unique emphasis in activities and accomplishments. Many provide service to community while they learn through STEM curricula, robotics projects, or service activities. 4-H is much more than agricultural endeavors.

Project activities, competitions, and presentations provide 4-H club members a venue for interacting with peers in a setting where they can share knowledge, work collaboratively, and produce events that enhance not only their local communities but other locales. Regional meetings are expensive to attend because of the long distances that separate communities in Alaska and also the rest of the United States.
