To provide support, assistance and services for the poor and needy in Sioux Falls, SD, and the surrounding area. Service is provided through thrift store resale of donated items and direct support for individuals and families in need of food, clothing, diapers, household goods, rental assistance, utility assistance, and other miscellaneous needs. Services are available all year round. \$40,000 was distributed (\$10,000 per conference) for assistance with rent, utilities, etc. on home visits to the needy. \$38,618 was spent on providing free diapers and wipes for approximately 840 babies 3 or 4 times during the 9 months. \$7,928 of clothing vouchers were distributed to 381 families. \$5,677 was distributed in food vouchers of \$50 each to 114 families. \$485 of free prescriptions was given to 6 people.
