We conducted three field courses within this year on tropical biology and primatology at the Los Amigos Biological field Station in southern Peru. The three courses were: December 2014 (4 scholarship students, 10 other students), May 2015 (1 scholarship, 6 other students), and July 2015 (3 scholarship, 12 full students). For all three courses, a minimum of two instructors were present, with an additional unpaid

Instructor (Director Timothy Paine) present in December, and a paid Instructor (Sean Williams, ornithologist) present in May 2015. All the

other instructors donated their services, except in May and July when one main instructor was compensated \$1500 per course (Director and Treasurer, Gideon Erkenswick Watsa). For all instructors, lodging was covered at the site, and the two main instructors' flights were also covered.

Program II: Research Assistantship Training

In this program, we worked primarily in the summer months and trained a total of 20 students (one of whom participated in the winter months). Research assistantships run from 4 to 10 weeks and cover four major research areas: wildlife handling, disease ecology, sensory perception and vocal communication. During these programs, a field team of managers conduct research at the site and supervise the training of each student. Our managers and senior researchers do not receive compensation, but stay is covered for two lead researchers at the site.

Program III: Scholarship Program for Field Courses

We offered a total of 10 scholarships to students during the year, 8 of whom were able to make it to the site and attend the field courses. Students came from Mexico, Brazil, Peru and the United States. The program covers lodging and food at the site, transportation from the closest town to the site, and stay locally for one night before and after the program. Applications for this scholarship are reviewed blind by a grants/scholarships committee headed up by Director Julia Maki. All students submit an essay response to a prompt for each scholarship and are evaluated by a minimum of two reviewers. Fluency in English is a prerequisite since the courses are conducted in English at the site.
