The Organization utilizes donated services to sort medical supplies for transport in support of those in need using other non-profit organizations throughout the state of Arizona, the United States of America and in foreign locations, as well as providing financial assistance to organizations with similar initiatives. In the fiscal year ending September 30, 2015, the Organization was able to rescue \$2,988,729 worth of medical equipment and supplies through the donation of these professional services.

Missionaries: The Organization works with local, regional, and international partners to help establish sustainable projects and programs for children and their families living in poverty.
