Advocacy and Organizing NARAL Pro-Choice America Foundation works at the national and state level to effectively use grassroots power, communication strategies, and our policy prowess to push government to protect and advance reproductive freedom and abortion access With activists in all 50 states, in FY 2015 NARAL supporters took more than 800,000 actions through our campaigns to stand up for their reproductive rights We also work closely with our state affiliates and network of campus programs throughout the U S Following a rash of attacks on abortion clinics in 2015, NARAL launched and led a clinic violence campaign pushing the U S Department of Justice to investigate the attacks for what they are-domestic terrorism We delivered a letter asking for the investigation signed by 140 ally organizations and doctors who provide abortions, as well as petitions signatures from more than 300,000 supporters We also partnered with our California chapter to craft language, organize more than 40 partners and allies, and mobilize thousands of activists to pass critical policy-the Reproductive FACT Act-that will ensure the women of California get truthful information about their reproductive health care options We mobilized almost 30,000 Californians to sign petitions and contact officials, and rallied a range of supporters, including healthcare workers and faith leaders, in support of this policy NARAL also exposed so-called crisis pregnancy centers (CPCs) with a national report that covered 10 states and looked at how CPCs use deceptive practices to lure pregnant women to their facilities in an effort to deny them access to a range of health care services, including abortion We released our report in conjunction with 11 affiliates, which published their own state-level reports, with coverage in New York Magazine, LA Times, NPR, Yahoo! News, RH Realty Check, Jezebel, Bustle, Ebony, Cosmopolitan, AllGov, Truthout, and Salon, as well as MSNBC, which produced a special video using data and investigator experiences solely from our report Prior to our report release, we also worked with Vice to provide key research for its own report examining CPCs ("Misconception") NARAL intervened at the national level in 2015 when Congress tried and failed to pass a 20-week abortion ban, organizing our Reproductive Freedom for All Speakout and collecting 143,000 petition signatures We then pivoted to the states, collaborating with our state affiliates to lead our #StopTheBans Day of Action across nine states, calling on extremists to stop the onslaught of state-level bans NARAL and our teams in North Carolina, Washington, Texas, Minnesota, Colorado, Maryland, Massachusetts, Ohio, and Virginia organized our activists to turn out, and collected over 50,000 signatures telling policymakers to #StopTheBans, mobilized over 550 activists to call officials to #StopTheBans, reached over one million on this issue, including on Twitter with our hashtag #StopTheBans Partnerships are also critical to our work NARAL organized over 100 small businesses and 4,000 citizens to stop anti-choice Congressional leaders from repealing anti-discrimination policies in Washington, DC We worked with a range of partners, including ACLU of Nation's Capital, and businesses large and small, new and institutional We also teamed with several allies-including UltraViolet, Working Families Party, and Democracy For America-and collected over 100,000 signatures demanding that Netflix extend its newly announced unlimited parental leave policy to all employees, including hourly workers who were left out, but who often need it most And Netflix listened, later expanding its policy to all workers

Policy Our policy team operates at both the national and state level-including working closely with our affiliates-to track proactive, pro-choice policy and anti-choice restrictions on reproductive health care throughout the U S Our policy team tracks several hundred bills each year and advises our national team and state affiliates through regular consults Additionally, our policy staff was as a critical component on several policies last year, including the Reproductive FACT Act in California, noted above We also successfully produced our 24th annual edition of Who Decides? The Status of Reproductive Rights in the U S , which provides a comprehensive look at the status of women's reproductive freedom across the U S and is a definitive educational resource on how the current climate affects women's ability to access reproductive health care

Communications Mobilizing, organizing, and educating are central to our work, to reach our activists and the public, we must find new, creative avenues to centralize reproductive freedom issues In the past year, NARAL has worked to engage a broader range of media targets, specifically those that represent cultural and constituency-based audiences, such as Cosmopolitan, Vice, Ebony, and online forums that reach younger, more diverse audiences We have also made strategic investment in digital platforms a key priority in recent years, growing our social media audience 28% in 2015 and using creative ways to not only broaden our audience and bring more people into the fold, but deepen engagement among our existing supporters, such as by hosting Tweetchats and Ask Me Anything sessions on the popular online community Reddit In 2015, as part of our #7in10forRoe celebration of the Roe v Wade anniversary, we reached over 2 million on social media, and were retweeted by the White House and Yoko Ono We are leveraging new ways to reach our audience, including more than 10 million when we posted a skit from comedian Amy Schumer that mocks the ridiculous hurdles women face getting birth control Our post was retweeted by dozens of celebrities and received recognition from BuzzFeed, Elle, and Amy Schumer herself NARAL also called out Gallup last year for a highly misleading poll that claimed that "Fewest Americans Satisfied with Abortion Policies Since 2001 " We sent our memo to more than 30 national reporters and media talkers in order to publicize the problems with this poll, as well as help shape and influence the narrative The media often rely on these polls for their stories, which are read by thousands and shape the discussion, and it's critical that we call out a misleading poll when we see it
