The Zoning Practice periodical is published quarterly and helps guide those who write and administer development codes, monitors all the latest trends in local land-use controls, and brings the reader current news and ordinance excerpts. Each quarter APA's Planning Advisory Service (PAS) publishes a new PAS report providing authoritative guidance on current issues and innovative practices. APA celebrates excellence in planning through our Great Places in America program. Annually, APA recognizes a total of 30 great neighborhoods, streets, and public spaces of exceptional character, quality, and planning.
