



PROTECTION ACT THAT WOULD PROHIBIT ABORTION AFTER FIVE MONTHS POST-FERTILIZATION-AT WHICH POINT, UNBORN BABIES CAN FEEL EXCRUCIATING PAIN THE UNITED STATES IS ONE OF ONLY SEVEN COUNTRIES WORLDWIDE THAT PERMITS ABORTION AFTER 20 WEEKS, INCLUDING NORTH KOREA AND CHINA THE PAIN-CAPABLE BILL COULD SAVE 13,000 UNBORN BABIES EACH YEAR FROM A TORTUOUS DEATH IN SUPPORT OF THE BILL, FRC MOBILIZED THE GRASSROOTS TO CONTACT THEIR REPRESENTATIVES AND SENATORS, WORKED ALONGSIDE OUR ALLIES IN CONGRESS, HOSTED THE BILL'S CO-AUTHOR, REP TRENT FRANKS (R-ARIZ), FOR AN EVENT AT OUR HEADQUARTERS, AND SPOKE AT TWO PRESS CONFERENCES ON CAPITOL HILL THE BILL SUCCESSFULLY PASSED THE HOUSE IN MAY, BUT FELL JUST SHY OF THE 60 VOTES IT NEEDED IN THE SENATE IN SEPTEMBER HOWEVER, WE'RE GAINING MOMENTUM TOWARD VICTORY THAT'S WHY FRC WILL CONTINUE TO PUSH FOR THIS AND OTHER COMMONSENSE LAWS THAT PROTECT WOMEN AND THE UNBORN FRC HAS ALSO WORKED EXTENSIVELY IN SUPPORT OF THE BORN-ALIVE ABORTION SURVIVORS PROTECTION ACT WHICH WOULD MAKE IT A CRIMINAL OFFENSE TO ALLOW INFANT SURVIVORS OF ABORTION TO DIE, EITHER FROM NEGLECT OR ACTIVE KILLING THE BILL PASSED THE HOUSE IN SEPTEMBER WITH UNANIMOUS REPUBLICAN SUPPORT, BUT IT STILL FACES HARD-HEARTED OPPOSITION FROM DEMOCRATS THAT'S WHY FRC WILL CONTINUE TO WORK ALONGSIDE OUR ALLIES, INCLUDING THE BILL'S AUTHOR, REP TRENT FRANKS (R-ARIZ), TO SEE THAT ALL BORN-ALIVE INFANTS ARE PROTECTED BY LAW WE'VE PROMOTED PROTECTIONS FOR BORN-ALIVE INFANTS THROUGH POLICY LECTURES, WASHINGTON UPDATE EMAILS, OP-EDS AND WASHINGTON WATCH RADIO BROADCASTS IN MARCH, FRC TOOK UP THE CAUSE OF LT COMMANDER WES MODDER, A CHAPLAIN IN THE NAVY THE 19-YEAR VETERAN, WHO HAD SERVED WITH THE NAVY SEALS, WAS STRIPPED OF HIS DUTIES FOR SHARING THE GOOD NEWS HE WAS FREEDOM COALITION STARTED A PETITION TO EXONERATE CHAPLAIN MODDER THAT EVENTUALLY GARNERED OVER 100,000 SIGNATURES IT WAS DELIVERED TO THE PENTAGON ON MARCH 30 IN ADDITION, FRC WORKED WITH MEMBERS OF FIGHT ON SGT MARTLAND'S BEHALF WHILE AWAITING A RESPONSE FROM THE PENTAGON AND THE ARMY IN HOUSTON, FIVE PASTORS HAD THEIR SERMONS AND OTHER PRIVATE COMMUNICATIONS SUBPOENED BY THE MAYOR AFTER THEY EXPRESSED OPPOSITION TO A PROPOSED CITY ORDINANCE THAT WOULD GIVE SPECIAL PRIVILEGES AND RIGHTS TO PEOPLE BASED UPON THEIR SEXUAL BEHAVIOR, INCLUDING ALLOWING A MAN TO ENTER WOMEN'S RESTROOMS AND OTHER PRIVATE AREAS IF HE IDENTIFIES AS A WOMAN THE "HOUSTON FIVE" WOULD NOT BACK DOWN, AND FRC, FRC ACTION, AND FAITH FAMILY FREEDOM FUND ACTIVELY STOOD WITH THEM OVER THE PAST YEAR ON NOVEMBER 2ND, 2014, FRC ORGANIZED I STAND SUNDAY, A POWER-PACKED NATIONWIDE SIMULCAST TO SUPPORT THE TARGETED PASTORS OVER 7,000 PEOPLE PACKED THE PEWS OF GRACE COMMUNITY CHURCH IN HOUSTON, WHILE OVER 3,300 CHURCHES AND HOME GROUPS JOINED IN FROM ALL 50 STATES TO STAND FOR RELIGIOUS LIBERTY WITH THE PUBLIC BACKLASH, THE MAYOR FINALLY RELENTED ON THE SUBPOENAS WHEN THE "BATHROOM BILL" WAS PUT TO A VOTE, IT WAS OVERWHELMINGLY DEFEATED BY 61% OF THE VOTERS--A HUGE WIN FOR RELIGIOUS LIBERTY!IN ATLANTA, THE MAYOR FIRED FIRE CHIEF KELVIN COCHRAN BECAUSE OF HIS RELIGIOUS BELIEFS, AFTER 34 YEARS OF DISTINGUISHED SERVICE AS A FIREFIGHTER KELVIN OBTAINED PERMISSION FROM THE CITY'S ETHICS DEPARTMENT TO SELF-PUBLISH A BOOK ON BIBLICAL MORALITY FOR USE WITH HIS MEN'S BIBLE STUDY, YET THAT SAME BOOK KELVIN'S BEHALF AND DELIVERED OVER 31,000 PETITIONS TO ATLANTA'S CITY HALL KELVIN SPOKE AT OUR WATCHMEN ON THE WALL PASTORS CONFERENCE IN MAY, AND WE FEATURED HIS STORY IN OUR UPDATE EMAILS, ON SOCIAL MEDIA AND ON WASHINGTON WATCH RADIO
