	See Schedule O Carilion Franklin Memorial Hospital, part of Carilion Clinic, is a not-for-profit healthcare organization committed to improving health outcomes for every patient while advancing the quality of care in the community it serves Located in Rocky Mount, VA, this 37-bed hospital offers a wide range of medical and surgical services, including convenient outpatient and emergency department services Carilion Franklin Memorial Hospital exists to serve the health care needs of its community, regardless of patient ability to pay Franklin's acute hospital admitted 1,452 patients and provided 4,957 days of care during the year Hospital programs include provision of nursing care, extensive outpatient and inpatient surgical and endoscopic services, and diagnostic imaging services including CT, MRI, and mammography Franklin provides a number of services targeting the specific health needs of its population, including diabetes management, home health and hospice, physical, speech, and occupational therapy programs, and cardiac and respiratory rehab Franklin also provides an emergency department with 24-hour care, emergency transportation, and a chest pain and stroke program With 21,131 visits, Franklin's emergency services are a critical component of the health safety net in its service area, acting as a primary health provider for a significant number of uninsured patients, who comprise 22% percent of emergency department visits Franklin also supports community screenings and education on chronic disease prevention and management, sponsoring over 171 events touching over 4,693 people In furtherance of its mission, Franklin provides extensive uncompensated care Stated at cost, charity, charity-eligible bad debt, and unreimbursed Medicaid costs for the year exceeded \$3 million

In addition, CFMH serves as an active partner in current community coalitions conceived to help address community health needs. These organizations are typically grant-supported and comprise of a diverse representation from the community. The coalitions are as follows: The Healthy Community Action Team coalition (HCAT) is supported in part by the Virginia Foundation for Healthy Youth (VFHY) grant to fight childhood obesity and is facilitated by STEP, Inc. and Virginia Cooperative Extension. Focus on Response and Education to Stay Healthy (FRESH) coalition addresses health and safety issues that impact pre-teen, teen populations and young adult populations and is supported by a Strategic Prevention Framework-State Incentive Grant (SPF-SIG) through Virginia Commonwealth University. A State-funded grant for suicide prevention supports the Franklin County Suicide Prevention coalition, which is coordinated through Mental Health America. Healthy Roanoke Valley (HRV), a coalition formed after the 2012 Roanoke Valley CHNA consists of over 50 community partners. HRV's service area includes Franklin County and is addressing access to primary care, access to mental health care, access to dental care, improved coordination of care, and general wellness. CFMH officials will communicate the priority areas of community needs identified through the assessment process, and work within the coalitions to encourage the focusing of community resources on these needs. Lastly, ongoing processes will be developed to track progress of improvements. Priority Areas Not being Addressed and the Reasons Multiple other needs were identified during the CHNA process, including a high uninsured population, access to services for the elderly, dropping out of school, and the high cost of services for insured (co-pay, deductible, and premium). CFMH will not focus on those initiatives in the scope of this project due to the fact that the CHAT did not identify those issues as being the most pertinent community needs. It would not be prudent to spread limited hospital and community resources across too many initiatives.

This committee is made up of Board members of Carilion Clinic, a related organization, who do not have a conflict of interest with any of the executives being reviewed. This review was performed in September and October 2014. A similar review was last performed in October 2015. This review included review of a comprehensive report from an outside compensation consultant specializing in healthcare organizations for select positions and the prior year's report on all of the reviewed positions. The reports reviewed by the Committee included a detailed comparison of total compensation and each element thereof, including base salary, bonuses and other cash compensation, and benefits, including deferred and retirement benefits. Compensation was compared to a peer group of organizations similar in size and structure to the organization, which was reviewed by the Compensation Committee. Detailed minutes of the meetings of the Compensation Committee are kept and approved at the next meeting of the Committee, setting forth the deliberations and decisions regarding executive compensation.
Part I, Line 4b	Select members of management participate in a Pension Restoration Plan. This plan provides a benefit equal to the normal retirement benefit that would be payable to the participant were it not for the Qualified plan's legislative restrictions on compensation and payable benefits, less the actual benefits under the Qualified plan. The CAA shall be distributed in a lump sum upon the earliest of (i) remaining employed by Carilion until the deferred vesting date for such account, (ii) disability, (iii) 24 months following involuntary separation from service without reasonable cause, except that Carilion at its discretion may make a partial tax distribution upon separation, or (iv) 24 months following voluntary or involuntary separation from service with reasonable cause if the participant does not enter into competition with Carilion Clinic during the 24-month period following separation from service. Upon the death of the participant, the plan shall pay the participant's beneficiary according to plan terms. Select members of management participate in a Defined Contribution Supplemental Executive Retirement Plan (DC SERP) in which the employer at the discretion of Carilion Clinic's Compensation Committee makes a contribution to an account established on its books for each eligible participant. If a participant ceases to be a participant prior to the vesting date, the account shall be forfeited. A lump sum distribution shall be made upon the participant's vesting date, death, or disability. Payments during the calendar year under these plans included the following: Nancy Howell Agee \$341,789.
Part I, Line 7	The organization pays annual bonus compensation to management based on scorecard performance. This review was performed in September and October 2014. A similar review was last performed in October 2015. The reports reviewed by the Committee included a detailed comparison of total compensation and each element thereof, including base salary, bonuses and other cash compensation, and benefits, including deferred and retirement benefits. Compensation was compared to a peer group of organizations similar in size and structure to the organization, which list was reviewed by the Compensation Committee. Detailed minutes of the meetings of the Compensation Committee are kept and approved at the next meeting of the Committee, setting forth the deliberations and decisions regarding the compensation of these executives. In addition, the Compensation Committee annually reviews the compensation plan and philosophy for all vice presidents and senior vice presidents, as well as all employed physicians and physicians in leadership roles.
