See Schedule O Carilion Tazewell Community Hospital, part of Carilion Clinic, is a not-for-profit healthcare organization committed to improving health outcomes for every patient while advancing the quality of care in the community it serves. This 56-bed hospital primarily serves the counties of Tazewell and Russell in Virginia, and Mercer and McDowell in West Virginia. Carilion Tazewell Community Hospital (CTCH) exists to serve the health care needs of its community, regardless of patient ability to pay. CTCH's acute hospital admitted 617 patients and provided 2,462 days of care during the year. Hospital programs include provision of nursing care, outpatient and inpatient surgical and endoscopic services, and diagnostic imaging services including CT, MRI, and mammography. CTCH provides a number of services targeting the specific health needs of its population, including physical, speech, and occupational therapy programs, home health services, bone density testing, and a cardiac rehab program. CTCH also provides an emergency department with 24-hour care and emergency transportation. With 10,728 visits, CTCH's emergency services are a critical component of the health safety net in its service area, acting as a key health provider for a significant number of uninsured patients who comprise nearly 18% percent of emergency department visits. CTCH supports community screenings and education on chronic disease management, sponsoring 29 events touching more than 718 people. In furtherance of its mission, CTCH provides extensive uncompensated care. Stated at cost, charity, charity-eligible bad debt, and unreimbursed Medicaid costs for the year totaled \$1 million.

Carilion Roanoke Memorial Hospital serves as a Level One Trauma Center with EMS services that include three EMS helicopters, six first-response vehicles and 38 Advanced Life Support Ambulances. The findings clearly demonstrate the need to address substance abuse and psychiatric issues, and obesity prevalence, as well as access to primary care. The high cost of services to the uninsured is impactful to vulnerable populations and was seen by the CHAT to have high feasibility to address. To address the needs of the community, Carilion Tazewell Community Hospital will develop a multi-disciplinary team to ensure that resources are aligned with the needs identified during the Community Health Needs Assessment. The team will initially consist of CTCH employees, but add membership from community agencies as needed to ensure improvements are achieved in the identified areas of focus. In addition, the Town and County of Tazewell recently completed a workshop to kickoff a vision for economic development for the area. This project will lead to the creation of a strategic plan for the town. CTCH will actively participate in this project, in particular on the Community Health subgroup. This will provide a forum for alignment of community resources with identified community needs. Activities recommended for this group are very consistent with the CHNA findings: pilot and experiment with approaches to addressing prescription drug abuse and the Tazewell Wellness Movement. Lastly, ongoing processes will be developed to track progress of improvements. Multiple other needs were identified during the CHNA process, including dental care for children, access to vision care, transportation and access to in-home care. Dental care is being addressed via the development of a new dental school, already under development. The process used by the CHAT to prioritize needs identified access to vision, transportation and in-home care as lower priorities. The number of items was limited to the top five so that resources are focused and effective.
