See Schedule O Carilion Tazewell Community Hospital, part of Carilion Clinic, is a not-for-profit healthcare organization committed to improving health outcomes for every patient while advancing the quality of care in the community it serves. This 56-bed hospital primarily serves the counties of Tazewell and Russell in Virginia, and Mercer and McDowell in West Virginia. Carilion Tazewell Community Hospital (CTCH) exists to serve the health care needs of its community, regardless of patient ability to pay. CTCH's acute hospital admitted 617 patients and provided 2,462 days of care during the year. Hospital programs include provision of nursing care, outpatient and inpatient surgical and endoscopic services, and diagnostic imaging services including CT, MRI, and mammography. CTCH provides a number of services targeting the specific health needs of its population, including physical, speech, and occupational therapy programs, home health services, bone density testing, and a cardiac rehab program. CTCH also provides an emergency department with 24-hour care and emergency transportation. With 10,728 visits, CTCH's emergency services are a critical component of the health safety net in its service area, acting as a key health provider for a significant number of uninsured patients who comprise nearly 18% percent of emergency department visits. CTCH supports community screenings and education on chronic disease management, sponsoring 29 events touching more than 718 people. In furtherance of its mission, CTCH provides extensive uncompensated care. Stated at cost, charity, charity-eligible bad debt, and unreimbursed Medicaid costs for the year totaled \$1 million.

Upon the death of the participant, the plan shall pay the participant's beneficiary according to plan terms. Select members of management participate in a Defined Contribution Supplemental Executive Retirement Plan (DC SERP) in which the employer at the discretion of Carilion Clinic's Compensation Committee makes a contribution to an account established on its books for each eligible participant. If a participant ceases to be a participant prior to the vesting date, the account shall be forfeited. A lump sum distribution shall be made upon the participant's vesting date, death, or disability.
