 The American Center for Mongolian Studies is an academic organization promoting scholarship and research about and in Mongolia. The organization provides support services to students and faculty conducting study or research in Mongolia at its full service resource center and library in Mongolia. It also conducts a variety of public outreach and educational activities including lectures and language training.

 Fellowships/Conferences/Lectures the organization supported two fellowship programs with grant funds received at the beginning of fiscal year 2015 (October 2014) and in fiscal year 2014 from the US State Department and the Henry Luce Foundation. The programs provided \$29,467 in fellowship awards to 7 US students and faculty. Fellowships support field research and language acquisition for students and faculty. In addition, the organization held conferences and public lectures in Mongolia in support of the fellowship programs and as part of the organization's public outreach goals. These activities were organized by staff in Mongolia.

4b (Code:) (Expenses \$ 107,932 including grants of \$ 65,000) (Revenue \$ 128,751)
 Resource Center and Library in Mongolia the organization maintains a fully staffed resource center and research library in Ulaanbaatar, Mongolia. The Center is housed in the Ulaanbaatar City Library and is overseen by a full-time Resident Director. The Resident Director is supported by a US Director hosted at the Center for East Asian Studies at the University of Pennsylvania. Primary support for the center comes from the US Department of Education, US Department of State, Henry Luce Foundation, The Asia Foundation, and donations. The resource center offers visiting US and international scholars a comfortable research environment which includes computers, office equipment, and a research library collection with over 4,000 volumes. The organization regularly acquires new books for the library in both the US and Mongolia. Grants supporting these activities in the current year were received at the beginning of fiscal year 2015 (October 2014).

 The ACMS administers the Books for Mongolia program, with funding support from the Asia Foundation in Mongolia. The ACMS receives upwards of 40,000 donated textbooks from the US twice per year, and handles distribution to interested institutions (schools, libraries) in every part of the country.

The ACMS uses grant funds to support operations in Mongolia. The grants are monitored by management through review of grant agreements and knowledge of the requirements and restrictions. The Resident Director in Mongolia is responsible for maintaining financial records for the office in Mongolia. Each month he submits a copy of the accounting books and scans of receipts to the US Director, who reviews the records concurrently with his preparation of the US books. The office in Mongolia generally receives transfers to cover operating costs from the US office, which is facilitated by a wire transfer by the Executive Director. The Mongolia office maintains six accounts at a Mongolian banking institution, 2 in US\$ and 4 in Mongolian tugrks. The office also maintains a petty cash account in dollars and tugrks that normally should not exceed \$200 in balance. All transactions are recorded with receipts and monthly statements from the banking institution. Each year the Executive or US Director visit the Mongolia office to review operations and verify records are being handled and stored properly.
