ANIMAL SHELTERS - For the nine-month period ended September 30, 2015,
the Atlanta Humane Society provided care and found homes for 6,156
animals surrendered to our facilities. In addition to accepting
animals from the metropolitan Atlanta community, animals were
transferred from other animal organizations throughout the Southeast to
our shelters for adoption. AHS also actively participated in the
rescue and rehabilitation of animals from puppy mills, animal hoarding
situations and dog fighting operations. A total of 9,600 animals were
spayed or neutered in an effort to combat the pet overpopulation issue
in our community, including 5,127 surgeries performed as part of our
low-cost, high volume spay/neuter program.

VETERINARY CENTER - The Atlanta Humane Society operates a full-service
charitable veterinary hospital providing affordable care for the
public. For the nine-month period ended September 30, 2015, 4,147
animals received services at our veterinary center, with many of the
services being rendered at low or no cost.

EDUCATION - Staff and volunteers engaged in a wide variety of humane
education initiatives over the past year, including tours of our
facilities and classroom presentations, as well as adult presentations.
These programs focus on the proper care and treatment of animals, the
work done by the Atlanta Humane Society as well as the importance of
programs such as spay/neuter in ending companion animal homelessness.
Additionally, the Atlanta Humane Society is fortunate to have over 560
dedicated and active volunteers who assist in the day-to-day operations
of the Organization and special events with over 62,336 hours being
contributed throughout the year.
