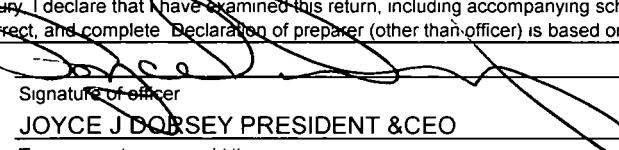

CSBG Total grant provided and spent is \$1,776,575. Capital expenditure of \$1,628 were later deducted for capital expenditures, therefore leaving a balance of \$1,774,947 as a current year's expenditure. The program supports services that prevent homelessness and hardship due to delinquency in rental and utility expenses payments. It also provides educational and life-skills trainings, such as budgeting and energy conservation. The CSBG grant generally supports most of the other programs and services of the agency. Three thousand five hundred and seventy-five (3,575) households were served in this fiscal year.

4b (Code) (Expenses \$ 5,526,960 including grants of \$) (Revenue \$ 5,562,691)

LIHEAP The revenue amount of \$5,562,691 was received during the year. This is an energy program which targets eligible low-income households and assist them in the direct payments of their energy bills to avoid disconnections and hardship. During the year, 15,054 households were served. Remaining and earned administrative fees for the program of \$35,731 was transferred to unrestricted funds for unrestricted expenses.

YOUTHBUILD DOL This is a \$902,150 three-year grant from September 2012 through December of 2015. As of September 2015, a total of \$809,621 revenues and expenses had been received and spent. For this fiscal year a total of \$145,637.47 was received and spent on tracking and motivating the graduates and closing out the program. In this fiscal year 30 youths were tracked and monitored. The overall objective of the program includes training the out-of-school youth from the ages of 16-24 whose lives were misdirected by lack of education, poor problem-solving and anger management skills, despair, and criminal behaviors. Through this program, clients also obtain their GED certifications. The program also provided case management, counseling, and job readiness and placement services to the youths. These eligible youths received training, with 80% receiving skill certification in carpentry in addition to receiving their GEDs.
