	Mississippi Nurses' Foundation (MNF) had a successful year as it continued to promote proper handwashing and infection control with 30 elementary schools in Mississippi, through a partnership with the Mississippi Department of Health, Mississippi Department of Education and the Mississippi Hospital Association. The Car Tag Scholarship program continues to increase with nursing students and nurses seeking degrees across the educational continuum (AD, BSN, MSN, PhD, DNP). A total of \$102,000 was awarded. MNF offered a \$1,000 scholarship to every school of nursing in the state of Mississippi. A total of \$18,000 was awarded. MNF hosted a successful wine basket campaign to raise money for operating expenses. MNF co-sponsored a Selected Reading Dinner Theater in Southwest Mississippi. Community College to support nurses in Southwest Mississippi and raise money for operating expenses. MNF is in its fifth year funding of Department of Health-Office of Tobacco Control grant for nursing students. The grant provides stipends for 20 nurses to attend Mississippi Nurses Association's annual convention and it teaches nurses and nursing students about the dangers of tobacco usage. MNF hosted a successful silent auction during the Mississippi Nurses Association annual convention. The event profited nearly \$5,000. MNF continues to increase the number of healthcare professionals seeking approval to offer continuing education to other healthcare professionals.
