THE FINANCIAL RESULTS PRESENTED IN THIS RETURN REFLECT DONOR UNRESTRICTED AND TEMPORARILY RESTRICTED CONTRIBUTIONS. AN UNRESTRICTED CONTRIBUTION IS AVAILABLE FOR USE WITH NO RESTRICTIONS OF TIMING OR USE.
