This represents less than 17% of total officer compensation. Health or social club dues/fees. SwRI pays the membership cost for two officers at two social clubs. These memberships are used primarily for business meetings. Any personal charges are paid by the officers.

The Institute has a noncontributory defined benefit pension plan, which is a grandfathered 457 plan, that was granted to Institute officers who were employed as of April 30, 1981. Benefits are provided through a group annuity contract. The last active participant, J. Dan Bates, retired in September, 2014. He will receive a monthly benefit for his lifetime, with a twenty-year guarantee. As required under Treasury Regulations, the present value of his future benefits is subject to FICA and Medicare taxation in the year that the vested amount is reasonably ascertainable. This occurred at his retirement in 2014. He had already exceeded the FICA Wage Limit for 2014, however, the present value, which was \$4,618,480, was required to be included in his 2014 Medicare Wages. Accordingly, it is included in the Other Reportable Compensation shown on Schedule J, Part II, Col. (B)(iii), as Col. B reports all amounts reported as Medicare Wages on Form W-2. It is also included in Reportable Compensation on Form 990, Part VII, Sec. A, Col. (D). This amount does not reflect the payments made to him, but is a reportable amount solely for Medicare Tax purposes. The actual benefit paid in 2014 was \$75,495. Schedule J, Part II, Col. (F) shows the portion of these Medicare Wages that were reported in prior years as accrued benefits related to this plan.
