As early as 1977, AGA has provided strategies and implementation that improve the standard of living and general welfare of residents in the project area through housing programs and support services These improve the economic viability of area commercial corridors through neighborhood commenal revitalization strategies In the early 1900s, AG was the commercial and cultural center for San Antonios Mexican-American community but this was followed by decades of severe public and private neglect A Master Plan was developed under the auspices of the AGA by residents, businesspersons, and the City of San Antonio in cooperation with the San Antonio Development Agency SADA leading to the implementation of a 3 5 block Urban Renewal Project to restore and enhance the communitys traditional role Since then, AGA has facilitated millions being invested into physical and human development, including Single Family Housing, 3 Senior Housing communities, historic building preservation, transforming El Parian Incubator into a Business Accelerator, and more

Established as a Community Development Corp in 1979, AGA is a neighborhood based organization AGA provides numerous community empowerment opportunities including education, advocacy, and engagement activities to local tenants and residents within the Avenida Guadalupe Neighborhood area Recently, AGA has engaged residents in Ready 2 Work, Ready 2 Learn, and Ready 2 Own programs which offer services in the areas of workforce development, housing counseling, connectivity to technology, and device proficiency Specific eduational opportunities which have been provided by AGA include Asset Preservation Emergency Repair programs and HUD certified Counseling

During 30 years of service the AGA has invested in economic and housing development, stimulating commerce while preserving the physical and spiritual character of the AG neighborhood AGA offers culturally significant events to educate and provide the community with opportunities to experience traditional Mexican holidays, such as Cinco de mayo and El Diez y Seis AGA sponsors the largest Mexican American Cultural Procession bringing thousands of citizens and visitors together in one of the most economically challenged neighborhoods in the nation - underpinning positive neighborhood interaction and providing a local neighborhood commenal revitalization strategy keeping businesses and patrons engaged, involved, and committed to community In response to recommendations made by the Urban Land Institute Advisory Service Panel Report of 2006, AGA sponsors an economic development strategy accelerating professional development of micro-entrepreneurs engaged in the creative economy through maintenance of a strong social network existing in the Guadalupe cultural arts district
