Our outreach and education efforts have resulted in growing our support list to over 5,800 individuals, including supporters from 44 states. Over 80% of our supporters are from the region of eastern Washington through northwestern Montana. Our most effective form of printed communication remains our newsletter, put out 4 times a year and distributed at events and to over 85 locations throughout the region from Spokane to Libby to Missoula and many points in between! We also distribute our quarterly newsletter as well as a weekly events/updates message via email.

We continue to see a substantial and growing number of visitors to our website, providing information on the value of preserving the wilderness

We have used both the trail maintenance and wildlife classes to engage students from many local schools and regional schools from the middle school, to high school and college level. We continued our Scholarship Program for high school seniors and an Essay contest in Sanders County for the Middle and High Schools.

We hosted or participate in many community events to engage the general public and our supporters alike including our annual "State of the Scotchmans" in May where we update supporters and the community on our progress and activities. In spring 2015, we continued a series of monthly Educational Forums in Lincoln County, MT examining the foundations of Community Prosperity with an eye to how conservation plays a fundamental role in a community's culture and economy.
