The organization provides counseling to pregnant women regarding prenatal and parenting issues to assist mothers in making the best decisions for their children. The organization assists birth mothers with medical costs, transportation to and from medical appointments, food, toiletries, and other living expenses. For birth mothers who choose adoption, the organization places the adoptive children in safe, stable, and loving homes. The organization receives adoption fees from adoptive parents, including application fees, home study fees, and placement fees. For birth mothers who choose to keep their babies, the organization provides them with counseling and connects them to other community agencies that may provide assistance. For the tax year ending September 30, 2015, the organization received calls from 23 pregnant women, worked with and provided assistance for 22 women, and placed 6 babies for adoption.

The organization's staff provides educational programs to promote adoption awareness and to educate pregnant women about their options. The expenses associated with these educational programs include the costs of materials that the organization prepares and distributes to participants as well as the cost of advertising campaigns to publicize the option and benefits of adoption to the general public. The organization also makes presentations to community groups, including local rotary clubs and Children's Protective Services, to promote adoption awareness.
