The Festival provided 8 concert nights including 2 symphonic concerts, and folk, world, country/bluegrass, popular, jazz and blues, including a family concert with the community orchestra formed by Maestro Gary Shelton and including seniors, children, and other community members.

The Festival conducted the 5th Grade Outreach, bringing a small symphony and conductor to each 5th grade class in Bonner and Boundary counties, including private and home study school children, to introduce them to the musical instruments that will be available to them for instruction starting in the sixth grade. We also provide musical instruments to the schools and to students who could otherwise not afford them. Further, the Festival supports the Youth Strings Orchestra.
