Wildlife restoration AES volunteers work with the U S Forest Service and Az Game and Fish Dept on collaborative projects to maintain and enhance wildlife habitat Programs also incorporate Boy Scout Eagle Scout Projects AES volunteers, employees and contractors hauled over 50,000 gallons of water for wildlife, restored and maintained over 50 wildlife water catchments and 7 dirt water tanks When completed the water projects will add over 5 million gallons of capacity for new water Projects and volunteers worked on riparian restoration, creek channel rebuilding, fence removal and enclosure maintenance, cleared over 200 acres of jack pines for grassland restoration, removed 4 miles of unnecessary barbed wire fence, maintained riparian cattle enclosure fencing, built log fences to protect critical wildlife habitat, restored many water catchments and troughs, and thinned brush around water catchments AES had over 250 volunteers working wildlife restoration projects and provided 350,000 in funding to Az Game and Fish Dept for wildlife from hunt tag auction sales and raffles
