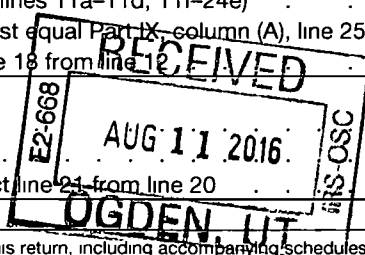

Protection and Advocacy for Individuals with Developmental Disabilities Program (PADD)
Numbers served: In 2015, DRW's PADD program provided advocacy services to 39 different group with potential of impacting 111,512 individuals with development disabilities. The number receiving individual advocacy services was 108 and 554 received training from our PADD program while 11,744 received information and referral services. 24 publications were revised or created and 84,477 visited our websites.
Advocacy Example In 2015 DRW continued its efforts to advocate for people with disabilities to have integrated work opportunities and fair wages. DRW provided extensive comments to the state's proposed transition plan to ensure Medicaid-funded home and community based services, including employment supports, are provided in integrated settings rather than isolating crews or sheltered workshops. DRW also advocated to enforce minimum wage rights for workers with disabilities through a class action lawsuit, which is currently pending. Our advocacy helped identify and successfully the need for a collaborative stakeholder process for evaluating the current subminimum wage approval process. The State Department of Labor and Industries convened this stakeholder process to discuss ways to protect against unjustified subminimum wages and invited DRW to participate.

Protection and Advocacy for Individuals with Mental Illness Program (PAIMI)
Numbers served: In 2015, DRW's PAIMI program provided advocacy services to 31 different group with potential of impacting 59,713 individuals with mental illness. The number receiving individual advocacy services was 433 and 1,442 received training from our PAIMI program at 24 events while 7,963 received information and referral services.
Advocacy Example. In June 2014, DRW launched a video and social media campaign challenging discriminatory questions on the Washington State bar application. The response was overwhelming. In July 2014, DRW sent a letter to the Washington State Bar Association (WSBA) that was signed by the deans of all three law schools in Washington as well as over a hundred law firms, agencies, attorneys, and advocates. In response, the WSBA formed a stakeholder group and asked DRW to join. After a thorough and extensive review, the group agreed that the WSBA should not be asking questions of applicants who seek mental health treatment. In May 2015, the WSBA sent our proposal removing the discriminatory questions to the Washington State Supreme Court, which is currently seeking public comment to the proposed revisions.

Amplifying Voice of Inmates with Disabilities Project (AVID)
Numbers served: In 2015, DRW's AVID Project provided Technical Assistance via telephone or letter 676 times to 426 individual prisoners. We continue to track trends in these calls to inform our systemic work. AVID staff visited 10 prisons, monitoring the conditions of confinement of 1,465 individual. AVID has opened multiple individual limited investigation and advocacy cases about a variety of disability-related issues including lack of medical care and mental health services, restraint and use of force, and suspicious death. Advocacy Summary: AVID staff have responded to emergency self-harm situations when the Washington State Department of Corrections (DOC) allegedly failed to act, helped inmates get medical attention, and assisted inmates who needed ADA accommodations for physical disabilities. AVID continues to meet regularly with DOC to discuss strategies to address systemic issues related to disability accommodations for inmates with disabilities, treatment for certain populations in segregation, and multiple other disability-related issues. DOC created a corrective action plan for a number of the issues raised and has been regularly updating AVID about DOC's plans to improve practices related to the use of restraint and treatment for inmates with personality disorders. At AVID's urging, DOC has also made steps to improve the process for inmates requesting disability accommodations.
