GROW serves as fiscal sponsor of fifty six community gardens and neighborhood projects that align with the mission and vision of the organization. GROW accepts and is responsible for grant monies and other donations received on behalf of a community garden or gardening project. GROW is responsible for ensuring the accurate accounting of all gifts, grants, payables, obligations and disbursements and that reporting requirements are met.

Seattle Market Gardens' mission is to help establish safe, healthy communities and economic opportunity through development of CSA and Farm Stand enterprises in low-income neighborhoods. Seattle Market Gardens is a partnership between in-city gardeners and consumers resulting in weekly deliveries of high-quality, farm-fresh, organic produce during the growing season and a weekly on-site farm stand. Seattle Market Gardens currently has two community-supported agriculture (CSA) gardens located in and worked by residents in Southeast and Southwest Seattle. The City of Seattle, P-Patch Community Gardening Program provides staff to work with these low-income communities to develop and manage the gardens. The P-Patch Community Gardening Program also works closely with respective community councils and neighborhood groups to set priorities for garden management and development.

GROW works to increase the number of P-Patch community gardens through an array of advocacy activities. GROW is committed to helping enable low-income people to garden, and provides gardeners with financial support (e.g., paying P-Patch plot fees and providing seeds and tools for shared use). GROW encourages gardeners to grow food for the hungry, either by contributing some of their own organic produce or by helping with the P-Patch garden plots designated for growing food for feeding programs. GROW also supports the distribution of produce raised in P-Patch community gardens that are delivered to community food banks and shelters. Volunteers logged over 25,000 hours during the year donating in excess of 30,000 pounds of fruits and vegetables to food programs. GROW provides support for the 89 P-Patch gardens in the form of volunteer site leader development, assistance with fundraising projects, liability insurance and small grants for infrastructure (e.g., tool sheds and communal eating spaces). GROW and the Seattle P-Patch Program are uniquely positioned to expand the community gardening effort because they have 40 years of experience in collaborating to build and manage gardens, as well as in nurturing the communities that are created when people come together to grow food. GROW's education mission is carried out through publication of the P-Patch Post, a quarterly newsletter that provides seasonal gardening tips, recipes and stories about inspirational gardeners. GROW is a member of Food Resource Network Federation. The Food Resource Network Federation was formed by area food providers seeking to move beyond the band-aid response to people trying to meet their food needs.
